I/We grant the Colonial School District permission to investigate the information provided in this application and hereby **Authorize Release of Information** from Local, State, Federal taxing authorities, local Municipal governments (Plymouth-Whitemarsh and Conshohocken), Utility Companies to include Telephone, Electric and Sewer/Water, US Postal Service, Landlords and Apartment Complex managers to the Colonial School District Residency Investigator.

I further understand and agree that I bear responsibility to notify Colonial School District should any of the above circumstances change.

I further understand and agree that I am aware of the legal consequences of providing false information in this sworn statement, specifically that:

"A person who knowingly provides false information in the sworn statement for the purpose of obtaining free transportation services for a child in a school district for which the child is not eligible commits a summary offense and shall, upon conviction for such violation, be sentenced to pay a fine of no more than three hundred dollars for the benefit of the school district, or to perform up to two hundred forty hours of community service, or both. **In addition, the person shall pay all court costs and shall be liable to reimburse the school district for an amount equal to the cost of the transportation services calculated in accordance with the prevailing Bus Rate service contract". The current Bus Rate for the 2011/2012 school year ranges up to \$230.00 per day.**
