225 Awards - Student Activities

1. High School Athletic Awards - P.I.A.A.

- (a) All administratively recognized champions, both individual and teams shall receive an appropriate award for their achievements;**
- (b) League Champions, District Champions, Inter-District or Regional Champions shall receive an award not to exceed \$30.00 in value;**
- (c) The School District will recognize all student athletes who achieve the title of “State Champion.” This refers to placing first in the activity they participate;**

The Board will recognize such person(s) in an appropriate manner consistent with the level of accomplishment;

The Athletic Director will verify the championship;

- (d) State finalists, both individual and team, shall receive an award not to exceed \$35.00 in value;**
- (e) All letter winners shall receive these special awards. Letter winners are determined by the guidelines as published in the student handbook;**
- (f) A committee, consisting of the principal or his designee, the athletic director, the head coach of the sport involved and a student representative shall determine the type of award to be given;**
- (g) Financing of these awards shall be from the refreshment stand. Additional funds, as needed, shall be made available from athletic gate receipts.**

2. High School Non-Athletic Awards - Clubs

Students participating in an administratively approved club who qualify for sanctioned and juried regional and/or state culminating competitions shall be recognized for their accomplishment by the School Board.

3. High School Non-Athletic Awards - Music

(a) *All band, orchestra and chorus members who qualify for an administratively approved, sanctioned and juried regional and/or state-level competition shall be recognized for such accomplishment by the School Board.*

(b) *All band, orchestra and chorus members participating in an administratively approved, tiered competition that is organized by a state chartered governing board shall receive an appropriate award not to exceed \$30.00 in value.*

(c) *Payment for band championship awards shall be made from refreshment stand receipts which are derived on the evening of the Cavalcade of Bands. Such receipts shall be deposited in the student activity account which derives its funds from band concepts, competitions, festivals, et cetera.*

4. Scholastic Awards – High School

One Honor Roll is compiled at the end of each year and is based upon the final grades in all subjects.

This Honor Roll shall consist of the following two (2) categories:

Scholastic Honors – Non-weighted Quality Point Average of 3.0 or greater and no grade lower than a B- Honor Roll Certificate;

Distinguished Honors – Non-weighted Quality Point Average of 3.75 or greater and no grade lower than a B- Honor Roll Certificate.

5. Scholastic Awards – Middle School

(a) Titles:

(1) Distinguished Honor Roll;

(2) Honor Roll.

(b) End of Year Awards for Honor Roll Three out of Four Report Periods:

(1) Grade 7

a. Distinguished Honor Roll, three out of four report periods-Distinguished Honor Roll Certificate;

b. Honor Roll, three out of four report periods – Honor Roll Certificate.

(2) Grade 8

a. Distinguished Honor Roll, three out of four report periods in seventh and eighth grade.

Distinguished Honor Roll, three out of four report periods – Distinguished Honor Roll Certificate.

b. Honor Roll: Honor Roll three out of four report periods in sixth, seventh and eighth grades.

c. President's Education Award for Outstanding Academic Excellence – 3.5 average for all grades – 6, 7, and end of 2nd marking period for grade 8.
